SCG and OCG School Visits, 2021-2022

- The SCG OCG School visits (practical elements of the SCG and practical elements of the OCG) will take place during the period 16 January 17 February.
- The practical elements will take place in schools and you will receive 1 visit if undertaking the SCG and 2 visits if undertaking the OCG.
- If you have applied to undertake practical elements for the SCG or OCG and have provided school details, then the SCG-OCG Office and visit supervisors are working on the basis that you have the permission of the school principal to undertake a supervised visit in the school.
- When schools re-open in January your supervisor will contact you, and, also_your school by telephone to
 advise of the date and time of your visit.
- If you are undertaking the practical element of the SCG or OCG then it is most important that your school are made aware of the date and time of your school visit as soon as it is made known to you.
- In normal circumstances you will receive 3 weeks notification of your visit, therefore the earliest that visits would take place would be from Monday 31st January onwards.

Q. What practical arrangements will be required.

A. It will be expected that the latest guidelines from the Department of Education/HSE will be complied with fully. The supervisor will require a chair in a well ventilated area that is the recommended distance removed from class pods. Q. What practical arrangements will be required.

A. It will be expected that the latest guidelines from the Department of Education/HSE will be complied with fully. The supervisor will require a chair in a well ventilated area that is the recommended distance removed from class pods. The practical element files should be left on the chair in advance of the visit to avoid unnecessary contact.

Q. What is the minimum length of time between OCG visits.

A. The OCG visits must be a minimum of 1 week apart. Therefore OCG visits cannot take place in the same week.

Q. Do I have to provide a yearly scheme in the file for the second visit?

A. Yes.

Q. Can I use the same weekly scheme in the file for the second visit.

A. No. As the second visit will take place in a different week a new weekly scheme will be required.
