NB: COMPLETION CERTIFICATE FOR THE IRISH LANGUAGE REQUIREMENT:

Candidates who have now completed and passed all required modules of the SCG or OCG, and who have completed the required Gaeltacht attendance weeks, and in the case of OCG, who have completed the required 120 days MUST apply now to the Irish Language Requirement Office for a completion certificate in order for your details to transfer to the Teaching Council. A completion certificate application form is available to download at www.ilrweb.ie.

NOTE: Applications for completion certificates must be submitted by email only.

NB: Your completion details can only transfer to the Teaching Council when you complete a Completion Certificate Application form.

REPEATING A MODULE:

Candidates who achieve a total mark in the 'Iomlán' column of 39% or less are required to repeat that module. For the SCG the mark obtained for a practical element may be carried forward to the August examination (provided the candidate has achieved a pass in the practical element) <u>or</u> the candidate may undertake the Practical element again with a view to improving their mark.

In circumstances in which the 'Practical Element' had missing elements a candidate is given the result 'F/Incomplete' which indicates Fail/Incomplete. In such circumstances the candidate must repeat <u>all</u> components of the module (Practical Element and Written Paper).

The repeat of the Practical Elements for candidates who must repeat a practical element, will take place as soon as possible. The three week advance notice will not apply, however you will receive a telephone contact from your supervisor at the earliest opportunity to arrange the time and day of your repeat school visit. It is vital that if you are undertaking a repeat of a Practical Element, that you submit a repeat application form <u>and</u> repeat school visit form as soon as possible (both available at <u>www.ilrweb.ie</u>).

VIEWING OF SCRIPTS:

Candidates who have achieved 0-39 in a module and wish to view their grade/script may email the Irish.

Language Requirement office (at **Viewing.scgocg@protonmail.com**) indicating your name, SCG or OCG, your examination/assessment number and the module/modules you wish to view. Please put **VIEWING** in subject title of email. You will receive an automatic reply. Closing Date for receipt of Viewing of Scripts email is Wednesday,8th May, 2024 at **5.00pm.** Viewing of scripts email requests will not be processed after this deadline.

Please note that viewing of grade/script is only available for module grades in 0 - 39 % range.
